# **Reaffirming our Commitment to Professionalism**

In September 1958, a conference for data processing workers was held at the University of Toronto. The proceeds from the conference and the vision of Dr. Calvin (Kelly) Gotlieb led to the formation of the Computing and Data Processing Society of Canada, now known as the Canadian Information Processing Society, or CIPS. CIPS in its early years was primarily a networking organization where practitioners gathered at meetings to learn about the coming changes in technology and to share ideas and experiences with one another. Today, CIPS is a federation of Provincial Societies, most of whom have legislative recognition for the I.S.P. designation. Our primary focus is professionalism; the integrity and competence of IT practitioners. As CIPS celebrated its 60<sup>th</sup> anniversary, our commitment to Professionalism was

reaffirmed by all Provincial Societies not only in words but also by our actions.

Our commitment to Professionalism was at the heart of the actions the Society took to preserve CIPS' presence in Ontario, to preserve the CIPS Ontario Act for right to title in the Province and to support those members in Ontario who valued our commitment to Professionalism. As privacy and cybersecurity issues mount, our mandate and responsibility as ethical practitioners to protect the public against the misuse of information technology has never been more important. Our ability to meet our mandate nationally is now strengthened by our actions to support members and the general public in Ontario.

The agreement signed by CIPS National and CIPS Alberta for the continuation of the Shared Services Agreement for the administration of the I.S.P. designation and other services was also a demonstration of our commitment as a Society to our Professionalism goals.

The National Board of Directors approved an updated CIPS Code of Ethics and Standards of Conduct which is now going through the process of being approved by Member Societies at their respective AGMs. While this approval process is a lengthy one, work on updating the CIPS Code of Ethics exam has begun. The CIPS Code of Ethics and Standard of Conduct is one of our foundational professionalism products and is core to our individual professionalism commitment. Our Ethics exam is a must for all aspirant certified members graduating from non-accredited programs.

CIPS has a long and respected history on the international stage. CIPS is a founding member of such international organizations as the Seoul Accord, the Federation of Enterprise Architect Professional Organizations (FEAPO), the International Professional Practice Program (IP3), the Institute for Certified Computing Professionals (ICCP), and the Information Federation for Information Processing (IFIP).

Through the relationship built by CIPS Saskatchewan with immigration officials in their Province, the Saskatchewan Immigration Nominee Program (SINP) required CIPS certification for potential immigration applicants applying under two IT related National Occupation Codes. CIPS received over 600 certification applications by fiscal year-end. While this has had a huge impact on increasing the global visibility of CIPS,

more important is its impact on CIPS' ability to share our dedication to professionalism to hundreds of international IT practitioners.

The SINP recognition of the CIPS designations demonstrates the importance of building and nurturing relationships. It also provides encouragement and a potential way forward for other Provincial Societies. The SINP recognition was the result of many years of relationship building. While the clear majority of certified applications have been for CIPS Saskatchewan, CIPS British Columbia, CIPS Ontario, and CIPS Nova Scotia have also seen increases in their international certified members and applicants.

The dramatic increase in applications naturally put a strain on our administrative processes related to assessing applications. While some administrative efficiency has resulted, the need for an online application and the automation of our administrative functions has never been more highlighted. Thank you to those CIPS members who have responded to the many calls for volunteers to help with both the education and experience reviews associated with processing applications. It is encouraging to see several our new international members also volunteering and showing their support of our commitment to professionalism.

CIPS' accreditation councils, ISTAC and CSAC, continued their important work of accrediting computer science programs in Colleges and Universities across Canada and abroad. The continued increase in student members introduces future IT professionals to CIPS' Professionalism products and commitment at an early stage in their career.

The CIPS Fellows Electoral Committee, working under the leadership of Patricia Glenn, FCIPS, I.S.P., ITCP, elected 8 new Fellows into their ranks this year. The collective wisdom of our Fellows is one of CIPS' biggest assets and we need to find ways to better engage them on a more consistent basis. Thank you to the many CIPS members who contributed their time and expertise to CIPS in support of professionalism.


## A look to 2018-2019
