- Protect the public interest and discharge with integrity all duties and services owed to the public, CIPS members, other IT professionals and clients.

With this obligation of protecting the public interest in mind, CIPS' Advocacy and Policy Committee is preparing a letter of response to Bill C-30 that will be sent to all MPs and Privacy Commissioners. Do you have any further comments or suggestions to make on the proposed CIPS response for consideration by the Advocacy and Policy Committee?

Once approved by the Board CIPS' position will be formally released and letters to all MPs and Privacy Commissioners will be issued. ## Getting Started with Cloud Computing

via Microsoft

A couple of months ago, I spoke to you about how [Office 365](#) and [Windows Intune](#) are great applications to get you started with Cloud Computing. Many of you emailed me asking for more info on what Cloud Computing is, including the distinction between "Public Cloud" and "Private Cloud". I want to address these questions and help you get started. Let's begin with a brief set of definitions and some places to find more info; however, an excellent place where you can always learn more about Cloud Computing is the [Microsoft Virtual Academy](#).



[Public Cloud computing](#) means that the infrastructure to run and manage the applications users are taking advantage of is run by someone else and not you. In other words, you do not buy the hardware or software to run your email or other services being used in your organization - that is done by someone else. Users simply connect to these services from their computers and you pay a monthly subscription fee for each user that is taking advantage of the service. Examples of Public Cloud services include [Office 365](#), [Windows Intune](#), [Microsoft Dynamics CRM Online](#), [Hotmail](#), and others.
